**Dear Commissioners, Rapporteurs, and Judges,**

I hereby submit the enclosed **Annex Zb-9 | Medical Analysis Report: Systematic Humiliating Forced Injections and Group Sexual Assault at Amager Psychiatric Hospital (June 2023)** as part of my ongoing complaint regarding systematic human rights violations committed by the Danish government.

This report documents a prolonged period of **institutionalized torture and sexualized medical violence** I endured at a public psychiatric hospital in Denmark, in violation of:

- The UN Convention Against Torture (Articles 1 & 16),
- The European Convention on Human Rights (Article 3),
- The Oviedo Convention and WMA Declaration of Helsinki.

These acts were perpetrated by state-employed medical staff under a coercive regime involving forced undressing, public injections, and systematic sexual humiliation. They resulted in profound and irreversible physical and psychological harm.

**I respectfully demand the following:**

1. **Formal classification** of these actions as torture and gender-based violence;
2. **Independent investigation and accountability** for the medical personnel

involved;

3. **State recognition and public apology** for the violations committed;
  4. **Full reparations**, including compensation and correction of falsified medical records;
  5. **Permanent prohibition** on any psychiatric intervention without my written consent.
